Notes to the Interim Financial Statements

01. Approval of the financial statement

The interim financial statements of the company for the period ended 30th September 2021 were authorised to be published by the Board of Directors on 10th November 2021.

02 Basis of preparation

The Interim Financial Statements of the Company have been prepared in accordance with Sri Lanka Accounting Standard (SLFRS/ LKAS) and provide the information required by the Colombo Stock Exchange and LKAS 34 on Interim financial reporting.

The accounting policies adopted in preparation of the interim financial statements are consistent with those followed in the preparation of the annual financial statements for the year ended 31st December 2020.

The interim financial statements do not include all the information and disclosures required in the annual financial statements, and should be read in conjunction with the Company's annual financial statement for the year ended 31st December 2020.

- 03 There has not been a significant change in the nature of contingent assets and contingent liabilities.
- **04.** No circumstances have arisen since the Statement of Financial Position date, which would require adjustment to or disclosure in the interim Financial Statements.
- **05.** The presentation and classification of the Financial Statements of the previous periods have been amended, where relevant, for better presentation and to be comparable with those of the current period.
- **06.** The Financial Statements do not include/classify actuarial gain/loss on retirement benefit obligation at the valuation is done at the end of the year 2020.
- **07.** The Company has adopted SLFRS 16 using modified retrospective method from 1st January 2019, without restating comparative information. Instead , it has recognized the cumulative effect of initially applying this standard as an adjustment to the opening balance of retaining earning at the date of initial application, as permitted under the specific transitional provisions in the standard.
- 08 Buildings of company were revalued during the fnancial year ended 31 December 2020 and the carrying value amounted to LKR. 778 Mn.
- 09 The Interim Financial Statements are not audited.
